Gerhilde, with a Spirit of Generosity

This season, Natalya Gennadi premiered as an artist in residence in our Civic Engagement Program, and as Gerhilde in *Die Walküre*. We caught up with her about her artistry and relationship with Pacific Opera Victoria.

How did you become interested in opera?

I always loved to sing. As a child, I remember hearing full symphonies in my head and trying to sing the intricate melodies. Unfortunately, I didn't sound like an orchestra at all, and my family encouraged me to take another path. I came back to music much later after earning a MA in Linguistics, and it was always opera that fascinated me. There is something very organic and primal about the energy exchange in a well-done opera. The great deal of sincerity in all this onstage drama is endlessly inspirational to me.

And the big dresses, of course.

What attracted you to Pacific Opera's Civic Engagement Artist Residency (CEAR)?

When I first read its description, I felt seen and heard, as if the missing piece of our opera industry had been found. We are collectively transitioning as artists and as an art form, and we need the space and time to explore the next chapter.

In the current socio-economic situation, creativity is becoming a privilege, and art is often limited to reliable, conventional craftsmanship. As a counterbalance, CEAR is inclusive and offers funding that frees up the creative mind. Guided by leading industry specialists, Rebecca Hass and the Pacific Opera team, no questions went unanswered.

How will this program help you in your future career?

The most significant aspect of the residency was that whenever I'd bring up an idea - no matter how outlandish - it would become a "how" instead of a "why." This year was transformative—I gained practical skills and creative confidence, materializing my concepts into actual projects. With support from Pacific

Opera, I produced a fundraiser featuring Ukrainian musicians, newcomers Georgiy Matviyiv and Maria Smolinska, along with Robert Holliston. Eventually, I hope to develop a concert series introducing new immigrant musicians to the Canadian music community, forging collaborations and employment opportunities.

As a multimedia creator, I am building a show called "Grandma's Shawl" for Soundstreams, Toronto. This idea was born in Victoria after hearing the story of Kokum shawls—originally Ukrainian khustkas given as gifts of gratitude to indigenous women.

At Pacific Opera, we are fortunate to witness a group of strong, creative, and courageous artists who are working hard on building a safer, multidimensional art space and art form. Its leadership and authenticity are unique. 
